

## PRIVACY POLICY www.dt4you.com

- 1. Online shop at www.dt4you.com pays particular attention to protecting the privacy of its Users. The abovementioned shop with due care selects and uses appropriate technical and organizational measures to protect the processed data, including IT securities such as data encryption systems. In particular, the shop protects the data against access of unauthorised persons as well as from being processed in a way that violates the mandatory regulations of law. Online shop at www.dt4you.com exercises permanent control over the process of data processing and limits access to the data as far as possible, giving appropriate authorisation only when it is essential for the proper operation of the website.
- 2. The basis for the processing of personal data is the consent of the Users, as well as statutory authorization for data processing necessary to conclude with the shop owner Firma Handlowo Usługowa MIKADO Import Eksport an agreement for the provision of services and execution and settlement of services provided by the abovementioned company within the shop at www.dt4you.com.
- 3. The provision of any personal data is voluntary. The provision of the data listed in § 4 of the Regulations is necessary to conclude with Firma Handlowo Usługowa MIKADO Import Eksportan an agreement for the provision of services within the shop at <a href="www.dt4you.com">www.dt4you.com</a>. Visitors to the online shop at <a href="www.dt4you.com">www.dt4you.com</a> can review the published offers for Goods without prior Registration and provision of personal data.
- 4. The data provided by the User during the Registration is used for accounting purposes, to contact the User as part of service of the shop at <a href="www.dt4you.com">www.dt4you.com</a> and for other activities related to the conclusion or performance of an agreement for the provision of services within the shop at <a href="www.dt4you.com">www.dt4you.com</a>, as well as for the conclusion and performance of the agreement concluded as a result of the Transaction in connection with the sale conducted by Firma Handlowo Usługowa MIKADO Import Eksport within the shop at <a href="www.dt4you.com">www.dt4you.com</a>. In cases specified in the Regulations, up-to-date User data, referred to in the preceding sentence, shall be made available to other Users, if and to the extent that is necessary for the conclusion and performance of the agreement concluded as a result of the Transaction. These data can also be used to verify whether the registrant meets the conditions required by the Regulations and provisions of law. Contact information with the User's consent are also used to send to the User by Firma Handlowo Usługowa MIKADO Import Eksport information about the company and the services it provides. At any time, the User can opt out of receiving such information.
- 5. Users data can be passed on to entities authorized to receive it under applicable laws, including to relevant judicial authorities. Users' personal data may be passed on to third parties in cases specified by Firma Handlowo Usługowa MIKADO Import Eksport and with the consent of the User.

- 6. In the cases when Firma Handlowo Usługowa MIKADO Import Eksport is informed that the User of the shop at <a href="www.dt4you.com">www.dt4you.com</a> uses it contrary to the provisions or the Regulations or applicable laws, Firma Handlowo Usługowa MIKADO Import Eksport may process the User's personal data to the extent necessary to establish the User's responsibility, provided that Firma Handlowo Usługowa MIKADO Import Eksport records for evidential purposes the fact of receipt and the contents of those data.
- 7. Firma Handlowo Usługowa MIKADO Import Eksport shall ensure that the privileges of the Users resulting from the Act on Personal Data Protection are observed, including the right to access own personal data and to amend it and the right to control and process own personal data on the basis specified in the aforesaid Act. Within the execution of the right to control the processing of own personal data, the Users have in particular the right to file in the cases specified in the Act on Personal Data Protection a written, justified request to cease processing of their personal data due to their particular situation, as well as to appeal against the processing of their data, when Firma Handlowo Usługowa MIKADO Import Eksport intends to process that data for marketing purposes or within passing on the personal data by Firma Handlowo Usługowa MIKADO Import Eksport to data controller other than Firma Handlowo Usługowa MIKADO Import Eksport.
- 8. Firma Handlowo Usługowa MIKADO Import Eksport provides the Users with the possibility to review and modify their personal data under the terms of § 4 point 8 of the Regulations. Firma Handlowo Usługowa MIKADO Import Eksport provides the Users with the possibility to remove their personal data from the personal data files in the event of withdrawal from the agreement, referred to in § 4 of the Regulations, as well as in other cases when it results from the applicable law. Firma Handlowo Usługowa MIKADO Import Eksport may refuse to remove the User data only in cases specified by applicable laws, in particular if the User has not settled all receivables against Firma Handlowo Usługowa MIKADO Import Eksport or Firma Handlowo Usługowa MIKADO Import Eksport obtains and stores the message, that the User, by their behaviour in the shop at <a href="www.dt4you.com">www.dt4you.com</a>, violated the Regulations or applicable law, and maintaining their data is necessary to clarify the circumstances and determine the User's liability.
- 9. Firma Handlowo Usługowa MIKADO Import Eksport uses IP addresses collected during internet connections for technical purposes related to servers administration. Additionally, IP addresses are used to collect general statistical and demographic information (e.g. on the region from which the connection is established). These data can also be combined with the data provided by the Users to implement services contained within the shop at www.dt4you.com.

Information collected via cookies allows for customising the services and content to individual needs and preferences of the Users, as well as cookies serve to develop general statistics regarding the use of the shop at <a href="www.dt4you.com">www.dt4you.com</a> by the Users. Turning off the option allowing for storing cookies in the browser substantially does not make it impossible to use <a href="www.dt4you.com">www.dt4you.com</a>, but it may cause some inconvenience.
